WeTel Television LLC., UAE (hereinafter referred to as the "WeTel") located at (Office No. 1428, Tamani, Street-1, Business Bay, Dubai)

And

MIMA Institute of Management, hereinafter referred to as MIMA Sr. No. 33/1, Balewadi, Pune-411045, India,

And

Realization Customer Services Pvt Ltd refer as Tourwatchout, 2241 - ATS Dolce, Zeta 01, Greater Noida, Uttar Pradesh - 201306, India

hereby agree to sign a memorandum of understanding (MOU) dated ____ day of ____ 2023, as follows to establish a mutual cooperation system and promote the reciprocal development of the three organizations.

Article 1 Purpose:

Both the WeTel and MIMA initiate a partnership for educational cooperation such as mutual information exchange including but not limited to student exchange, faculty exchange, collaborative research, consulting and support based on mutual respect and trust, and both with Tourwatchout for the purpose of extending requisite support in all coordination and arrangements for various educational programs.

Article 2 Scope of Cooperation:

A. WeTel & MIMA:

In order to achieve the purpose of Article 1, both parties will actively carry out collaboration in the areas mentioned below:



1. Mutual cooperation for human resources development, collaborated research, faculty development of both the organizations, consulting,
2. Education and facility support for fostering the growth of relevant business field,
3. Other areas of mutual interests and projects deemed necessary for the development of both organizations,
4. Mutual cooperation for training and development of students³ for both organizations.
5. Content production support.

B. Tourwatchout:

1. Extending all logistical and coordination support to both the above parties in conducting the educational initiatives such as study tours, academic tours,
2. Commercials for each of such assignments shall be discussed and finalized between the parties from time to time.

Article 3 Duration of Agreement:




This MOU shall come into effect on the date of signing of the three parties and shall remain in effective for unless either party notifies the other of its intention in writing to terminate with a notice of 30 days or revise the MOU, and will be considered as terminated in case of no activity within one year.
